#### ORDER:

In the G.O.1<sup>st</sup> read above, the Andhra Pradesh Departmental Tests Rules, 1965 were issued. Rule 14 (a) (iii) of the said rules provides that the duration of all tests shall be three hours except the 2<sup>nd</sup> Class Language test, which will be of 2 hours duration and rule 20 of the said rules provides that the time table for the conduct of the departmental tests shall be as in Annexure-III.

- 2. In the D.O.letters 2<sup>nd</sup> and 3<sup>rd</sup> read above, the Secretary, Andhra Pradesh Public Service Commission has stated that the Commission has decided to conduct departmental examination in objective type pattern of two hours duration and requested the Government to issue necessary amendments to the Andhra Pradesh Departmental Tests Rules, 1965.
- 3. The Government after careful examination of the matter, hereby accept the request of the Andhra Pradesh Public Service Commission and make the following amendments to the Andhra Pradesh Departmental Tests Rules, 1965, issued in G.O.Ms.No.1397, GA (Rules) Department, dated the 24<sup>th</sup> July, 1965:-

#### **AMENDMENTS**

- (I) In the said rules, for clause (iii) of sub-rule (a) of rule 14, the following clause shall be substituted namely,
  - "(iii) The duration of all tests shall be of two (2) hours duration".
- (II) In Annexure-III, -
  - (a) for the expression "9-30 am to 12-30 pm and 9-00 am to 12-00 noon" wherever it occurs, the expression "9-30 am to 11-30 am and 9-00 am to 11-00 am" respectively shall be substituted.
  - (b) for the expression "2-30 pm to 5-30 pm and 2-00 pm to 5-00 pm" wherever it occurs, the expression "2-30 pm to 4-30 pm and 2-00 pm to 4-00 pm" respectively shall be substituted.
